Brief:

- After experiencing several weekends when the # of moped/golf cart rentals & conduct of the operators became a serious issue, Council imposed a moratorium on increasing the # of such conveyances.
 - For 2023 franchisee is requesting 20 golf cart plates, the same # as was awarded in 2022.
 - For 2017 the # of mopeds was capped at the # that each company had in service during the summer of 2016.
 - For 2017 the # of golf carts was capped at the # each company had in service for 2016 + the # already ordered at the time the moratorium was imposed.
- Ordinance 2017-56, approved 1/9/18 in consultation w/ the business owners, approved the framework of a franchise agreement similar to the system in place for taxis.
- The franchise ordinance requires annual renewals.
- No changes since 1st reading.

Issues:

- Franchising allows Council to restrict the # of mopeds & golf carts available for rental. as well as the location of each rental business.
- Under the franchise terms each conveyance will be issued a City "plate" similar to a license plate. These plates assist law enforcement to track operational violations.
- This proposed ordinance:
 - Sets the location for rental conveyances.
 - Sets the # of rental conveyances allowed/location.
- Agreement is for a 1-year period, & must be re-approved annually.
