Brief:

- There are no requirements that businesses provide employee parking. While some businesses east of Kings Highway provide offsite parking or other arrangements at the employer's expense, most employees are left to solve this themselves.
- The lack of an employee parking program often results in those employees parking in non-parking places, & in a volume of tickets for illegal parking.
- The purpose of this program is to provide a low-cost alternative to illegal parking through a program specifically for the businesses located east of Kings Highway.
- The City currently offers 4 parking programs:
 - o Residential Parking Decals for any metered space (free).
 - o Non-Resident Decal for any metered space from 21st N to 6th S (\$100/year).
 - Weekly parking pass for any metered space (\$30/week).
 - Pay by the hour/day at any metered space (rate varies by location).
- This proposed resolution adds an annual \$50 Oceanfront Employee Parking Decal exclusively for employees of businesses located east of Kings Highway.
- Decals could be used only at POM (coin operated) meters (currently 1,465 in total).
- Street ends, paystation parking spaces & Mackay Meter spaces are considered prime parking spaces & could not be used for Oceanfront Employee Parking Decals.
- This program addresses the need for safe/reliable/inexpensive parking for these employees, & provides another layer of control for our parking ambassadors & MBPD.

Issues:

- The program would provide an additional option for safe, reliable parking to employees who are not provided parking by their employer.
- Staff will educate the public throughout this off-season season through the City's website & social media. Staff will also reach out to businesses near eligible POM parking spaces.
- In proposed resolution Council authorizes:
 - Creation of a new Employee Decal for businesses East of Kings Highway
 - o Current parking authority to issue decals and enforce the program.
 - o Use of related Program revenues consistent w/ the non-resident decal program.

Based on the current inventory of eligible spaces, average yearly revenue generated at these spaces, & proximity to the ocean, Staff does not anticipate much, if any, loss in revenue to the parking program.
