
I have served as chairperson of the Recreation Advisory Committee from the time of its conception in 2006. I would like to continue in this capacity for another term of service.

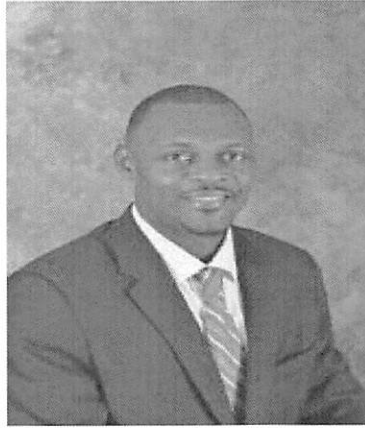


