Resolution R2020-25 to Direct the City Manager to Implement the Attached Emergency Health and Safety Order to Provide Financial Relief to City Businesses Suffering from the Economic Impact of the Coronavirus Health Event (Recreation Center Memberships and Utility Fees).

WHEREAS, on March 13, 2020, Governor Henry McMaster issued Executive Order No. 2020-08 related to 2019 Novel Coronavirus ("COVID-19") and declared that a State of Emergency exists in South Carolina; and

WHEREAS, many customers purchased annual memberships in those facilities according to the schedule of fees and charges in Ordinance No. 2019-030, the 2019-20 Budget Ordinance, Exhibit D-Recreation Fees and Charges, and because of the closings are unable to use the services during this time; and,

WHEREAS, many of the City's Water & Sewer customers, who pay according to the schedule of fees and charges in Ordinance No. 2019-030, the 2019-20 Budget Ordinance, Exhibit B-Schedule of Water and Sewer User Charges are suffering economic hardships brought on by the current emergency situation; and,

WHEREAS, owing to the emergency situation a number of city facilities have been closed and city services have been suspended; and,

WHEREAS, Chapter 8 of the Code of Ordinances of the City of Myrtle Beach provides special authority for certain extraordinary actions to be taken by the City Manager in dealing with emergency situations, including the emergency powers enumerated in Sec. 8-11; and

WHEREAS, among those extraordinary actions are (Sec. 8-11(h)) "[t]o waive, adjust or suspend any law, code provision or regulation prescribing the procedures for conduct of city business, or the orders, rules or regulations of any city agency, including but not limited to fees, policies and procedures, if strict compliance with any ordinance, resolution, order, rule or regulation would in any way prevent, hinder or delay necessary action in coping with the emergency or disaster, provided that such suspension shall provide for the minimum deviation from the requirements under the circumstances and further provided that, when practicable, specialists shall be assigned to avoid adverse effects resulting from such suspension;" and

WHEREAS, it is hereby determined that a public emergency affecting life, health, and safety does exist and
