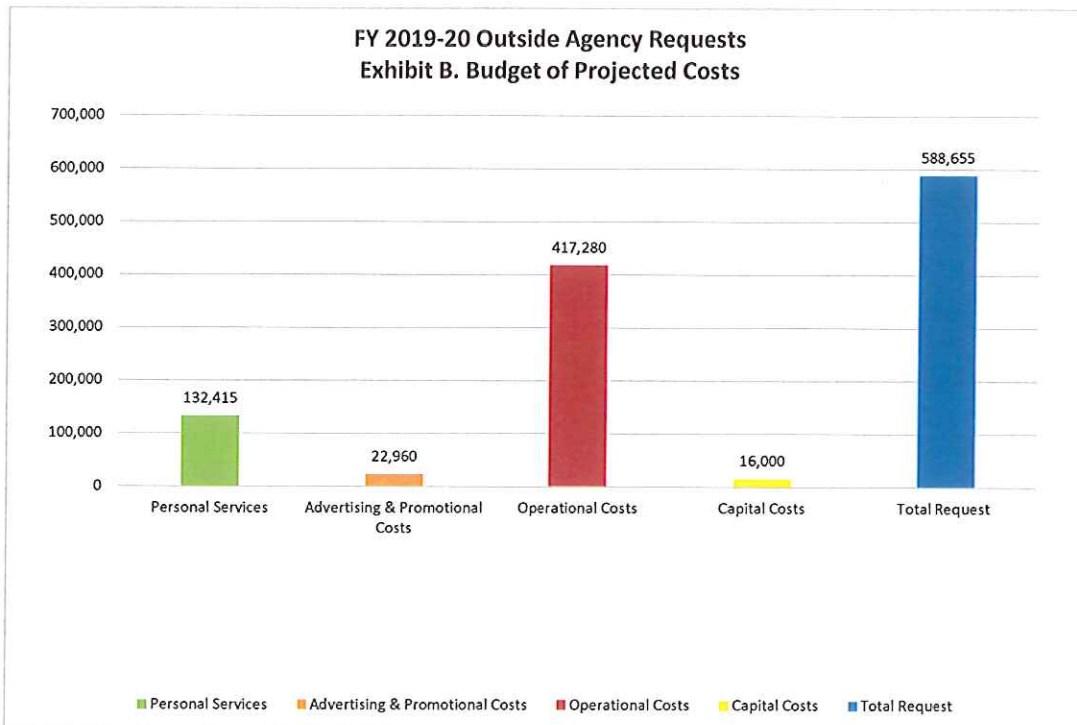

Our programs and activities give the youth and teens in our community an opportunity to enhance their academic success, improve their communications and leadership skills and to think about not only graduating, but plan for post-secondary education. Boys & Girls Club of the Grand Strand provides a safe & fun place with positive programs & activities for at-risk school-aged youth via a low-cost 9-week summer day camp program (which will include a new summer reading program that provides daily opportunities to build literacy skills) and a 39-week after-school program (that includes homework help, literacy & reading tutoring, character and leadership training, career training and STEM activities). We operate a program for grades 1-3 youth, as well as a TWEEN Program for grades 4-6 youth at our 304 Oak Street location at the First Baptist Church Family Life Center. The forensic interview is performed by a trained forensic interviewer and is observed by a team of law enforcement, social services, and other professionals as appropriate. This approach reduces the number of interviews a child victim may experience, thereby reducing the trauma to the child. It also provides for consistency in the information being provided and provides a forum for discussion and decision-making in a multidisciplinary approach. This multi-disciplinary approach along with the child friendly facilities, has helped increase criminal prosecutions and improve the outcomes for child victims of sexual assault.
